

# GET A CLUE: FASHION SCAVENGER HUNT




### **CLUE 8**

### HOW DID SHE DO IT?

Lilly was familiar with the Fashion Archives due to her research. She was able to swipe Charlie's ID the day he was fired. Charlie didn't realize for several days which allowed Lilly to become more familiar with the location and then preform her theft in the middle of the night.

### WHY DID SHE DO IT?

Lilly was doing extensive research on animal rights violations in various fashion industries. Inspired by the protests by organization like PETA and her volunteer work with Michelle Adams, she wanted to make a statement about how fashion can be harmful.

She thought stealing these items would cause more conversations. Each piece represented a key issue in the fashion industry.
